Registration Dates

Tuesday, June 17th, from 1:00 p.m. until 8:00 p.m. (FREE Loyola Mobile Clinic on site for physicals, 1pm-5pm)

Thursday, July 17th, from 8:00 a.m. until 8:00 p.m.

Monday, August 11th, from 1:00 p.m. until 8:00 p.m. (FREE Loyola Mobile Clinic on site for physicals, 1-5pm)

Tuesday, August 12th, from 1:00 p.m. until 8:00 p.m. (FREE Loyola Mobile Clinic on site for physicals, 3-7pm)

Any RETURNING students registered after August 12th will be charged \$20 late fee per student and may only register on Tuesdays and Thursdays between 9am - 12pm.

Student will begin 2-days after completion of registration.

Registration Fees

Fees for registering students includes \$30 Technology Fee which cannot be waived:

K-3 --- \$75

4-5 --- \$100

6-7 --- \$125

8th --- \$250 (Includes additional graduation fees of \$125)

Gym uniform fee is extra --- \$20 (required for Grades 6-8)

Payment Plans Available: 2 installments can be made; 1st installment due at registration
FINAL installment before the first day of school. **ALL FEES MUST BE PAID BEFORE 1ST DAY OF SCHOOL.**

Registration Health Requirements

The following students **MUST** have physicals to complete registration:

- All New Students
- All students entering Kindergarten (must be 5 years old by September 1st of this year)
- All students entering 6th grade
- All students entering 6th 7th and 8th grade must show proof of Tdap vaccination.
- Sports physical required for 5th – 8th grade

I certify that I understand the residency requirements to attend Cook County School District 92 and that I know the penalty for fraudulent registration. I am aware that I have 30 days to present proofs of residency. All documents must be within 30 days of registration date. Students who move into the District to live with relative or friends for the purpose of attending District 92 are not considered legal residents in the District and therefore cannot be admitted to the school. Illinois law provides that the residence of a student is deemed to be the same as the residence of the person who has legal custody and is the parent/guardian of the student and permits only students who are residents of the District to enroll and attend on a tuition-free basis. **Registration of a student who is not a resident in Cook County School District 92 is a fraudulent act. Any student found to have been fraudulently registered will be disenrolled from the district immediately. Parents or guardians making a fraudulent registration will be charged tuition of \$11,500 per year and may be charged with a Class C Misdemeanor and face legal action under Illinois school code (105 ILCS 5/10-20.12b).** The District may investigate the residency of any student before or after enrollment and require the involve persons to provide additional information to be considered by the district in determining residency. *Student registration is complete when the following requirements are satisfied:* RESIDENCY/AFFIDAVIT, HEALTH RECORDS, FEES/OBLIGATIONS

III. Warning and Affirmation:

Illinois law (105 ILCS 5/10-20.12b) has made it a crime, punishable by imprisonment and fine, to knowingly or willfully present any false information regarding the residency of a student for purposes of enabling that student to attend on a tuition-free basis or to knowingly enroll or attempt to enroll a student on a tuition-free basis when the student is known to be a non-resident of the District. The District will seek prosecution to the full extent of the law of any person who the District believes has committed any residency-related crime. Additionally, the District may initiate a civil lawsuit. **If any items presented to Lindop School District 92 for proof of residency are forged or altered you will be reported to the Broadview Police and charged with a Class 3 Felony (720 ILCS 5/17-3).** I affirm that I am a resident of District 92 and that the information presented in this Affidavit and in connection with any investigation of my residency or the residency of the student is true, complete and accurate. I understand that I may be investigated for my residency.
